I would like a PVG check for my own use to show to families or clients, as I work for myself & have regular, unsupervised access to children &/or protected adults.

I work for a personal employer, such as a family or individual, & have regular, unsupervised access to children &/or protected adults, and my personal employer wants to complete a PVG check for me.

I work for an organisation and my role requires a PVG check due to me having regular, unsupervised access to children &/or protected adults.

I'm a volunteer with an organisation in the voluntary sector & my role requires a PVG check due to me having regular, unsupervised access to children &/or protected adults.

If your employer wants a Scheme Record PVG check, your application needs to be countersigned by a registered Umbrella Body, such as us, before sending to Disclosure Scotland, and this is a service we can provide to your employer. Please ask your employer to contact us if this service is needed.

You need to discuss with your organisation, as they may be to arrange a **free** PVG check for you. An Umbrella Body called Central Registered Body in Scotland (CRBS) will be able to give guidance (see www.crbs.org.uk)
